

This letter is about the documents provided for explanation and request for an Injunction of Harassment.

- 1.) I do NOT engage with Christine Baker (privately or personally).
- 2.) I have NOT replied in any form to her postings (online) regarding myself.
- 3.) If, I am required to engage with Christine Baker, it is solely for work related communication through email (my work email), that is protected under the records retention laws. I only respond when advised.
- 4.) I do NOT intend to communicate with Christine Baker unless it is for a professional work-related matter in which I am instructed to do through my supervisor.
- 5.) I am the Administrative Assistant for Lake Mohave Ranchos Fire District, gainfully employed, currently working from home under the supervision of the Fire Chief with documentation under a physician that meets ADA requirement.

Christine Baker has published on her blog site (High Desert Dirt) and on social media defamatory remarks regarding me, this breaches the 1st Amendment. I am heavily concerned with her ongoing attacks against me, which have caused anguish. I am concerned that she has tainted my professional reputation, my professional working relationships and my professional future. I am in fear that her cruel attacks could lead to more obstructive behavior. These malicious postings are not backed with any factually based information and are per se libel. I feel Ms. Baker has demonstrated reckless disregard, malice, negligence in ascertaining statements of truth, false & defamatory communication and abuse of conditional privilege.

I now face the reputation impairment through community standing, emotional distress and additional anxiety from Ms. Baker's reckless behavior.

I am asking, your Honorable, that you take into consideration the publications that were made by Ms. Baker (on the internet) and invoke an Injunction of Harassment for me to salvage my professional reputation, that has been tainted by Ms. Baker in such a demeaning manner. I am asking that you

notice her postings, possible future postings that she could make and that these could directly affect my ability to gain employment in the future and it has already directly affected my employment with Lake Mohave Ranchos Fire District. My ability to earn a living to support my family has been obscured and I may have to result in taking a less paying position due to her remarks that she's posted when and if I seek future employment. I have worked diligently in my professional life and I have obtained three degrees and am currently working on a fourth (MCC and GCU) and am a marketable person that is skilled and well-versed, I am strongly concerned for my livelihood.

If there is any contact that must be made between Ms. Baker and myself, I would request it's only related to LMRFD business only. LMRFD business is NOT defamatory remarks about me.

Ms. Baker is a citizen of Meadview, AZ who has displaced content against the LMRFD and is not a tax-paying citizen into the Fire District and who's property is NOT annexed into the District, she has chosen to spew these vicious remarks through publication.

Please see attached documents of the harassment / defamatory remarks Ms. Baker has posted online regarding me.

I am requesting the Court keep my address confidential.

Thank you for taking the time to read this, consider my concerns and request.
